# Preface

This is the Association of Professional Geoscientists of Ontario's (APGO) eleventh Annual Report to the Minister of Northern Development and Mines, the APGO membership, and the Ontario public. The purpose of this report is to present a comprehensive overview of the Association's activities during the past year for the benefit of the identified stakeholders and others.

The Association remained focused on four key areas throughout 2013 as per the 2011-2014 Strategic Plan:

Strategic Priorities	Strategic Directions
Marketing	Increase awareness of the geoscience profession
Membership	Grow membership and enhance value for members
National Leadership	Provide leadership on national and international mobility and standards
Government Relations	Working with government to strengthen APGO's role as regulator of Ontario's professional geoscientists

The Association continued to fulfill its duties in the areas of Registration, Complaints and Discipline, and Professional Practice.

Applications for registration continued to increase over the annual rate for 2012, resulting in an increase of 23% in membership. Especially encouraging is the significant growth in GIT (34%) and Student (400%) memberships. Complaints registered with the Association were either resolved, are currently under review, or have been forwarded to discipline.

The APGO works closely with Geoscientists Canada (formerly known as the Canadian Council of Professional Geoscientists) on national issues and is pleased with the progress of the Admission Support Tools project.

APGO signed a bi-lateral agreement with the Association of Professional Engineers and Geoscientists of British Columbia (APEGBC) to allow incidental practice between registered members in both provinces. APGO thanks the Ministry of Northern Development and Mines for their support in working towards amending the Registration Regulation, O.Reg. 59/01.

APGO remains committed to working with the Office of the Fairness Commission, Ministries of the Environment and Natural Resources as well as strategic partners in order to advance professional geoscientists in Ontario.

On behalf of the Council of the Association of Professional Geoscientists of Ontario (APGO), its committees and staff, it gives me great pleasure to present you with the APGO's 2013 Annual Report. This report again demonstrates our unwavering commitment and summarizes our activities that continue to support a strong and sustainable geoscience profession in Ontario. Our commitments and activities remain in line with the goals and objectives of the Ministry of Northern Development and Mines to protect the public, develop the mineral sector and develop the profession. APGO's audited financial report for 2013 and a list of volunteers that contributed to the success of the Association this past year are included in this report. We trust that you will find the APGO continues to meet our mandate, and that the Association is effectively governing the profession of geoscience in Ontario.

The APGO membership has continued to increase with over 2777 members as of December 31, 2013, including 1994 full or limited P.Geo.'s. We are particularly pleased to report that our efforts to engage student and Geoscientists-in-Training has met with success and membership in these categories has increased to 454 student membership and 266 GIT's. This strategic focus contributes to growth of the profession. These registration numbers mean that the APGO continues to be the largest geoscience-only regulator in Canada and that Ontario maintains the second largest population of professional geoscientists in Canada.

The APGO's Registration Regulation was previously challenged Divisional Court (2011 and 2012) and in order for APGO to fulfill its role as a regulatory body, further regulatory changes are still required and we have been working collaboratively with your ministry to ensure these improvements and enhancements to the APGO Regulations are approved as quickly as possible.

Association staff and volunteers continued to work on various national and international initiatives designed to encourage compliance with, and awareness of, the Act and to facilitate mobility. I would like to take this opportunity to thank you and the staff of your Ministry for working with the Association in 2012, and we look forward to increased relations through 2014 and beyond. The APGO trusts that you find the Annual Report interesting and informative.

#### **President's Report**



The APGO continues to grow and develop in many respects. The APGO team achieved many notable successes which are highlighted throughout this year's Annual Report.

It has also been a challenging year for many of our members and notwithstanding this we have seen an increase in

activity and engagement for which we are grateful. In these difficult times we have also seen great professionalism and camaraderie from our members.

#### Strategic Plan

Every five years the APGO revisits its Strategic Plan and last year a renewed strategic plan for 2014-2018 was set. This occasion gives your Association the opportunity to review its direction, receive valuable input from its members, ensure that our mandate as regulators of the geoscience profession (as enacted by the Government of Ontario) is upheld and plan for continuing professional development. Key elements of the strategic plan and work of the APGO are highlighted below:

#### Vision for the APGO

To be acknowledged as a trusted and respected geoscience authority that engages fully qualified geoscience professionals for the benefit of geoscience and society.

#### Mission

To protect the public by regulating geoscientists in Ontario and advancing professional practice.

#### **Strategic Goals**

- 1. Become an even more relevant, accessible and professional society by increasing our membership and the value we provide to members through varied initiatives.
- 2. Foster strong relationships and partnerships to leverage our efforts.
- 3. Work proactively to influence regulations, and
- 4. Continue to strengthen as a governing body.

The past year, our 11<sup>th</sup> year as a Professional Association and Regulator, had many highlights, a few of which I reflect on. In many respects the past year affirmed our status as a national leader in the field of professional geoscience. We have maintained strong regulatory requirements while simultaneously focusing on out-reach, professional development and networking: all to be an APGO that you can trust and where you can use '**P.Geo**.' with pride and distinction.

Membership grew again in 2013 to 2777 of which 1947 are full members. Of note is the significant increase in student and GIT membership from **310** in 2012 to **720** in 2013. The APGO has focussed on visiting all 14 contacting geoscience faculties and all geoscience students annually to increase awareness of the APGO and the national knowledge-based requirements to become a P.Geo. We will continue to build our relationships with the geoscience faculties, professors and students.

A positive relationship with our members is essential for an effective Association. During the past year we have started networking events in each of the regions. Each event has been a resounding success with our members coming together to meet, discuss common issues and engage with staff and Council. It is at these events that we are also very proud to deliver Fellowship of Geoscientists' Canada Awards to aeoscientists that have made significant contributions to the community and profession. These events will continue in the coming years and I encourage you to take time to attend the next event in your region.

Another highlight of the year was the signing of Incidental Practice (IP) Agreement between the APGO and the Association of Professional Engineers and Geoscientists of British Columbia (APEGBC) enabling our registered professional geoscientists to work up to 45 days (of incidental practice) in each other's province without registering. Both the APGO and APEGBC have taken a leadership role and stance on IP as it supports the modern reality of a highly mobile profession. This agreement is in its trial phase and has met with initial success.

APGO Council, staff and committee volunteers have been working throughout the year to improve the **Regulations** that legally 'govern'



the APGO, with the goal of increasing the effectiveness and efficiency of your Association. The amendments go before legislature for adoption in 2014.

The Association runs with a small team of staff, Council and committees, without which none of the achievements would have been possible and I thank you all for your hard work, advice and patience.

I was proud and privileged to serve as your President and at your service over the past year. Thank you for your support.

Finally, please join me in welcoming and giving your full support to your new President Mr. Dave Hunt P.Geo.

## Vice President's Report



Strong committees are essential APGO's to efficient operation. many Without our committees, registrations would take much longer, complaints would not be followed up and best practice guidelines would not be written. Approximately 150 councillors and volunteers serve 17 on our

committees and sub-committees, assisting us in carrying out our mandate. I wish to thank all committee members for their invaluable assistance. Yearly updates from each of the committees are presented below.

One of my areas of focus during the past year has been assisting in the preparation of our 2014 - 2017 Strategic Plan. Following an extensive questionnaire sent to each of our members, indepth interviews with select members from different fields of practice, and facilitating discussions with our Council and CEO, a new Strategic Plan has been developed that will focus our direction and activities for the next three years. We have begun to increase our presence throughout the Province by participating in more regional events where geoscientists gather, and we are holding more regional gatherings which provide our members with a chance to network and meet with our regional councillors and staff to discuss issues of importance. We plan to continue this regional outreach in the coming years.

In this electronic age, our profession along with others, is under a microscope more than ever and protecting the public means more than operating with scientific and technical expertise. It demands that we must also be aware of the myriad ever-changing policies and regulations with which we must comply in the course of our daily work. To respond to this, we have been developing more best practice guidelines for members, as well as sponsoring workshops and short courses throughout the Province dealing regulatory and compliance issues. with Geoscientists in Ontario work in the real world to solve real-world problems for the benefit of society. APGO, as a regulator, must support our members with realistic best practice tools to accomplish their goals.

Finally, I have been very pleased to see the significant increase in student and GIT members during the past year. This increase has been due, in large part, to the efforts of staff and regional councillors who have worked closely with universities to bring young geoscientists on I believe these young members will board. benefit from the increased knowledge and networking opportunities provided by APGO, as well as the more favourable employment professionalism opportunities their will encourage. In the coming year, we hope to increase our formal and informal mentoring opportunities for the students and GITs who will be our future professional geoscientists.

## CEO's Report



I am pleased to report on the activities of the APGO for the 2013 calendar year.

APGO focused on four main objectives in 2013: Engaging students in the APGO; More mobility for Professional Geoscientists; Effective Regulations; and Reaching Out to our membership. The

following is a more fulsome description of these objectives and outcomes.

#### More for Students – 400% Increase

APGO focused on increasing the number of students registered as members. At the end of 2012, 112 students were members of the APGO and this increased to 454 by December 31, 2013. We accomplished this objective by simplifying the registration process for students, making presentations at all 11 universities in Ontario that teach geoscience, meeting students at our PDAC booth in March, and developing an active Facebook page.

The students of today are tomorrow's APGO members and we wish to smooth the transition from student to Geoscientist in Training. Helping students take the right courses to meet APGO's knowledge requirements is essential. APGO created an on-line tool kit to help students choose the right courses for them. APGO volunteers, many from Council, visit universities each year to promote membership in the APGO and to answer questions regarding course selection.

#### More Mobile P.Geo.'s

APGO was pleased to sign a mobility agreement with the Association of Professional Engineers and Geoscientists of British Columbia (APEGBC) in 2013, effective January 1, 2014 to allow short term practice for P.Geo.'s from Ontario in BC and vice-versa. P.Geo.'s in both these provinces can practice up to 45 days in a calendar year in the host province without paying extra fees or registering. Some rules do apply to this agreement but it does foster more seamless transition of P.Geo.'s between Ontario and BC.

APGO is the only regulator of geoscientists in Canada that has two mobility agreements -

temporary mobility in Quebec and incidental practice mobility in BC. APGO commends its founder, Bill Pearson for his continuing commitment to mobility and for his major role in the agreement with BC.

APGO has mobility as a priority in its strategic plan and will continue to work towards making it easier for P.Geo.'s to more freely move about Canada.

## **Effective Regulations**

Starting in June 2013, APGO in partnership with the Ministry of Mines and Northern Development (MNDM) began to amend the provincial regulation that defines the APGO regulation process. APGO's regulations were passed by the Ontario Government more than 12 years ago and over time have needed to be refreshed. This has been a time-consuming process that we expect will be completed in 2014.

New regulations, if properly developed, will strengthen APGO's role as the provincial regulator for geoscientists.

## Reaching Out to Members

APGO has made a concerted effort to reach out to members by holding regional meetings hosted by our Regional Councillors. In 2013, regional meetings were held in Ottawa, Waterloo, London and London. More were held in early 2014. Response from those members who attended was enthusiastic. There is much value in professionals networking together to learn from each other in the spirit of fellowship.

APGO will continue to hold member networking events throughout Ontario. Field Notes newsletter is issued once a week rather than six times a year to provide members with more timely information regarding the activities of APGO and the geoscience sector.

All of this is done to create a better sense of community within the geoscience profession in Ontario.

Finally, I am thankful for the support of APGO's President, Andrew Cheatle and the entire Council. I am very impressed with the level of commitment this group has to the goals of the APGO and the staggering number of hours of volunteer time they are willing to give.



It is a privilege for me to serve as CEO and I look forward to working with Council and our membership to further advance this profession in Ontario and across Canada.

# **Committee Reports**

## **Registration**

Ian Macdonald, P.Geo. – Co-Chair Andrea Waldie, P.Geo. – Co- Chair Aftab Khan, P.Geo. Registrar

The role of the Registration Committee is to review all applications for registration and determine their acceptability for membership. This Committee also has responsibility for establishing academic standards for admission and the administration of the Professional Practice and Ethics Exam.

The Committee needed to meet monthly to handle the volume of applications being received. As of December 31, 2013, APGO's membership breakdown by class was as follows:

- 1947 P.Geo. (Full unrestricted Practising)
- 47 P.Geo. (Limited)
- 2 P.Geo. (Temporary)
- 61 P.Geo. (Non-practising)
- 266 Geoscientist-in-Training
- 454 Students



This represents a total increase in membership of 524 with a major increase in the number of students. The APGO also issued 189 Certificates of Authorization in 2013, an increase of 6 from 2012. The current list of members in good standing and Certificates of Authorization can be searched on the APGO website at: http://www.apgo.net.

Most universities in Ontario are now well aware of the academic requirements to become members of APGO. We are very happy to see that several institutions are contacting APGO in advance of anticipated course changes to ensure that knowledge requirements are still being met. Two members of the Registration Committee were selected as subject matter experts for Geoscientists Canada Admissions Support Tools Project. Their role was to provide advice in the creation of a competency profile for the profession of geoscience in Canada. Once completed and validated, this document will describe the job tasks a P.Geo is expected to have the ability to perform at the time of entry to independent practice. Competency is anticipated to be a tool for geoscience regulatory associations to use as part of the registration process.

The process of making changes to Registration Regulation continued in 2013 with numerous meetings between APGO and MNDM. Several iterations of the changes have been exchanged and it is hoped that the changes will come into effect in mid-2014.

The APGO wishes to express gratitude to the volunteer members of the Registration Committee for their ongoing dedication in assessing applications.

# <u>Complaints</u>

#### Alan Aubut, P.Geo. – Chair

The Complaints Committee reviews complaints received by the Registrar or the Association and currently has 27 members.

During 2013, there were no new complaints received by the Association. Three related cases, with the first received in 2011, have now been formally dismissed.

A "Case History" document has been compiled to assist future review panels. Other aspects of the committees' procedures continue to be under review to help improve the overall process.

The committee continues to meet, via telephone conference, every quarter. A formal training session was held during the 2013 Annual General Meeting.

# <u>Discipline</u>

# Wayne Caston, P.Geo., FGC, MCIP - Chair

The Discipline Committee is responsible for hearing and making determinations on cases of professional misconduct, malpractice, negligence or incompetence, brought against a Member or Certificate holder by a complainant. The Committee was called upon to convene two Hearings in 2013. Information on Hearing Panel decisions is available on the APGO web site, under 'Discipline'.

Regular meetings of the Discipline Committee continued to be held by teleconference on a quarterly basis. In 2013, the Committee focussed on:

- retaining a full complement of members reflecting the geographic areas of the province and the wide range of geoscience sub-disciplines;
- developing a Policies and Procedures for Discipline Hearings document for approval by APGO Council (approved in November); and
- continuing development of procedural aids to the Committee, particularly aids for making consistent decisions on penalties.

A training session was held on June 13, 2013 in Toronto in conjunction with the Association's Annual General Meeting. This session involved a presentation on the Hearing process, including notification, joint submissions, penalties and conditions. A discussion followed regarding details of the first Discipline Hearing held in March, with commentary from Carol Street, LLB



(Independent Counsel to the Discipline Committee) on 'lessons learned', in anticipation of the second Hearing held later in June. The session was attended by most members of the Discipline Committee and several members of APGO Council.

The Committee Chair and Vice Chair hold twoyear positions with the Vice Chair (Mike Jones, P.Geo.) moving to the Chair position on completion of the current Chair's mandate in June 2014. The Committee maintains a Standing Hearing Panel, composed of experienced professional and public members, and an alternate Panel, for immediate deployment if the need arises.

A note of appreciation goes to Sean Dickie, Ivan Severinsky and Amy Stevenson for their service, which ended in 2013, on the Discipline Committee.

## **Enforcement and Compliance**

## Stephen Wilson, P.Geo. - Chair

The Enforcement and Compliance Committee is responsible for working with the Executive Director/Registrar and APGO staff to ensure that the practicing geoscientists and firms offering geoscience services to the public in Ontario are appropriately licensed to do so. The committee's primary function is to provide policy and guidance to the Registrar and staff of the Association. The Registrar is an ex-officio member of the committee. The committee reports to Council.

The Association's Enforcement and Compliance policies and procedures were established in the period 2003 to 2005, and since that time the main focus of the committee has been to work with APGO staff on specific compliance issues. The APGO's enforcement and compliance efforts have increased since 2008 as a result of the focus brought to bear on this issue via the APGO strategic plan and through the efforts of the Registrar. The enforcement and compliance efforts have directly resulted in an increase in applications and membership, furthering the Associations mandate of public and environment protection through the registration of qualified individuals as geoscience professionals. In 2013, the committee continued assisting the registrar with the review of specific compliance files that were brought to the attention of the committee. The files brought forward included those with clear evidence of non-compliance with the requirements of the Professional Geoscientists Act concerning the practice of professional geoscience. The Committee made recommendations to Staff as to the next steps for the APGO to consider in regards to the individual files. These steps include potential legal action against non-compliant practitioners.

At the start of 2014, the Enforcement and Compliance Committee had 155 active files with no backlog. In 2014, regular committee meetings are scheduled to continue to assist staff in determining the appropriate response of the Association to chronic offenders, complicated files and for those instances of noncompliance that pose a serious or immediate risk to the public and/or the environment.

# <u>Communications and Public Awareness</u> Mark Priddle, P.Geo. – Chair

The Communications and Public Awareness (CPA) Committee is responsible for developing and managing a plan for communications and public awareness in alignment with the APGO Strategic Plan. The Committee is also responsible for overseeing the Association's newsletter, *Field Notes*. Committee members provided recommendations regarding Association outreach as well as communications to members and the public.

The Association published numerous articles over the course of 2013 in both its own Association newsletter, *Field Notes* and periodicals. Beginning in July 2013, *Field Notes* was hosted by MultiView.com. Most news items and all the advertisements in *Field Notes* are generated by MultiView.

Our key event was again, attendance at "Gemboree" in Bancroft in August. APGO maintained a booth during the event. This raised the exposure of the APGO in the community (students and public school teachers).





The Committee provided sponsorship and presented information on professional geoscience at the Applied Earth Science Research Conference (AESRC) at Western University in London.

While not directly under the CPA umbrella, various APGO Councillors and staff visited most Ontario universities offering a geoscience program in 2013 to present the concept of professional geoscience to hundreds of geoscience students. The Chair of the CPA hosted the first 'Regional Gathering' for APGO members in a number of years. It was held in Ottawa and attended by about 40 people, including some non-members.

## Governance

Dorene Weston – Chair

The mandate of the Governance Committee is to monitor the overall function of Council and the Association to ensure compliance with the Act, Regulations and By-laws. This year the Committee has also focused on draft by-law revisions and a conflict of interest statement for Council and committee members.

## **Finance**

#### A.R. (Tony) Lotimer, M.Sc., P.Geo. – Chair/Treasurer

The Finance Committee is a Standing Committee of Council responsible for general oversight of the finances of the Association. This includes (a) ensuring that financial policies and procedures of the Association are followed, (b) overseeing the development and approval of the annual budget, and (c) reviewing, on an ongoing basis, the financial performance of the Association with respect to the annual budget.

In 2013, the Association continued with a number of strategic initiatives in communication, enforcement & compliance, governance and upgrades to the website. Two hearings were held by the Discipline Committee in 2013 and there were some additional effects from the Divisional Court challenge in 2012. The costs associated with these activities were significant. However, the Association realized a

small net surplus for the year and remained in a healthy financial position at the end of 2013.

## **Nominations**

## Ian Macdonald, M.Sc., P.Geo., FGC - Chair

In 2014, the Nomination Committee identified positions on Council that would need to be filled in the upcoming year. Multiple email notices and articles in Field Notes went out to the membership for gualified candidates to fill the various positions on Council for the 2014 Election. These positions included Vice President, one Councillor-at-Large, South-East Regional Councillor and the North-West Regional Councillor. One candidate for each position came forward and agreed to stand for election to these positions in 2013.

The Nominations Committee has vetted the application package for each candidate, which included the nominee's curricula vitae, commitment letter and support from at least 10 APGO members. All nominees met the necessary criteria.

Based on the actions undertaken as described in this report, the Nomination Committee feels it has discharged its duties for this year.

## **Executive**

#### Andrew Cheatle, MBA, P.Geo. - Chair

The Executive Committee is responsible for implementing policy decisions of Council and providing management of the Association on behalf of Council. This committee may take interim action in the event of an emergency where time does not permit the meeting of Council.

The Committee is responsible for:

- Initiating proposals for submission to Council and review of budgets and expenditures
- The annual or periodic review of the CEO (Executive Director), Registrar and/or senior management
- Appoint committees to deal with management and administrative related matters that may arise from time to time



Other duties and responsibilities that may be assigned by Council from time to time

The Committee met every second month in 2013 – months when Council meetings were not held. Minutes from all Committee meetings were presented to Council for review at the next Council meeting.

# Non-Member Appointment Committee Visha Sukdeo, LL.B. - Chair

The non-APGO member public appointees contribute to Council by sharing their diverse insights and their wealth of experience in sectors and professions outside of geoscience. By fulfilling this role, the non-member public appointees represent the viewpoint of the public of Ontario on Council.

The Act stipulates that public appointees participate on key APGO Committees including the Complaints Committee, Discipline Committee, and the Executive Committee as well as on special panels required to review registration appeals. Non-member public appointees have satisfied this mandate during the 2013 year.

## **Professional Practice**

## Della Berwanger, M.Sc., P. Geo. - Chair

The Professional Practice Committee (PPC) is a standing committee of the APGO and is responsible for developing standards and guidelines for the practice of professional geoscience, developing an ongoing program of professional development, maintaining standards professional ethics, of and practice undertaking other professional matters as may arise from time to time. Several subcommittees exist to fulfill the various mandates of the PPC, and these subcommittees: include the following Environment, Geophysics, Geology, and Professional Development. Separate reports for the activities of each subcommittee have been prepared. These **Subcommittees** participate in the preparation and review of guidelines and industry standards relevant to their area of professional practice.

The Professional Practice Committee members generally meet by conference call several times within the year to discuss specific issues. Along with the Chairs of the Subcommittees, the PPC is comprised of volunteer members as well as the Past APGO President, and several current or former Councilors. The PPC engages the Subcommittee to focus on increasing guidance resources that address both general and specific professional practice issues. Limited specific issues needed to be The addressed by the PPC over 2013. Committee finalized the association's Guidance for Document Authentication for Council's approval, and this Guideline was uploaded to the association website for general membership use.

# Audit Committee

## Robert Gordon , P.Eng., MBA - Chair

The Audit Committee met this year in January and February to apply some oversight on the process and procedures of the overall audit of the 2013 financial statements.

We follow an established process and procedures and timetable to help ensure a timely audit. Bateman MacKay LLP is our auditor this year. Bateman MacKay LLP is headquartered in Burlington with offices in Mississauga.

At the time of the writing of this the audit is in midstream and is expected complete by the end of the month of March 2014. – The audit has now been completed.

# Subcommittee Reports

# *Geology Subcommittee* Ben Berger, P.Geo. - Chair

The Geology Subcommittee is a subcommittee of the Professional Practice Committee. The Geology Subcommittee's mandate is to support the Professional Practice Committee in fulfilling its mandate with respect to the practice of geology.



The Geology Subcommittee has been asked by council to review the guidelines set by National Instrument 43-101 regarding the completion of mineral exploration reports submitted to the Toronto Stock Exchange (TSE). No action has been taken pending clarification from the TSE as to the exact nature and purpose of the review.

APGO's Guidance on Document Authentication was finalized and approved by the Geology Subcommittee and the Professional Practice Committee and was posted on the APGO website in May 2013.

The Geology Subcommittee prepared a response to a member's question regarding the qualifications required for drill core logging on operation mine environments. The response was published in Field Notes.

# *Geophysics Subcommittee* Milan Situm, P.Geo. - Chair

The Committee did not convene in 2013 as there were no issues regarding professional practice, as it pertains to geophysics, that required attention.

# *Continuing Professional Development Subcommittee*

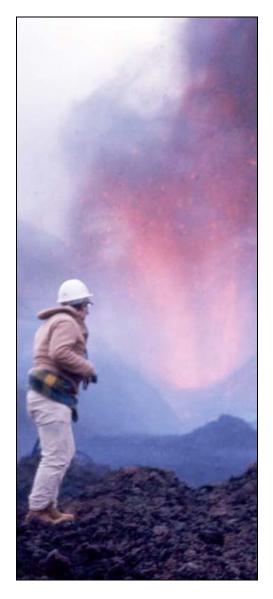

The Continuing Professional Development (CPD) Subcommittee held one meeting during the year. Due to issues with the CPD program identified by the membership, a Task Force of Council was struck to review the current CPD program and to make recommendations to Council. The Task Force is scheduled to make its report in early 2014.

# Student & G.I.T. Mentoring Subcommittee Milan Situm, P.Geo. – Chair

Milan Situm, P.Geo. assumed the chair position early in 2013. The committee convened twice in 2013. It was recognized that a mentoring program was needed similar to programs in other jurisdictions. This involved a base of volunteers as mentors that would be matched with employed GITs or P.Geo.'s that wish to improve their soft skills.

A "Speed Mentoring" session was initiated for the first time at the 2013 AGM. There were six experienced volunteer P.Geo.'s who had the opportunity to speak to 35 students. The use of the word 'mentoring' in this case is a misnomer because the majority of the students were not employed but rather seeking ideas on the background employment history of the P.Geo.'s including their education, daily responsibilities and their field of geoscience applications. The two hour session was considered to be successful and it will be occur again at the 2014 AGM.

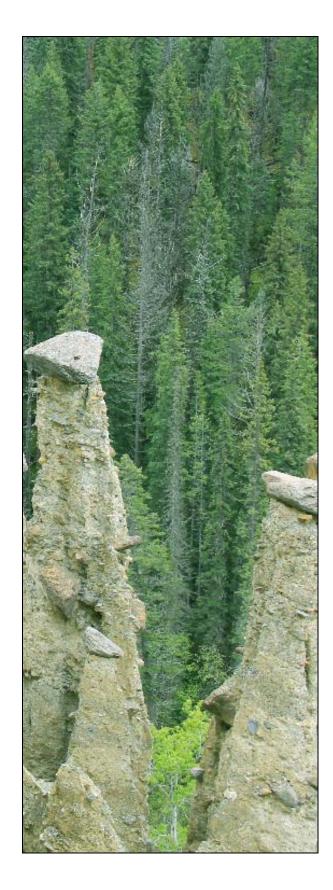

# THE ASSOCIATION OF PROFESSIONAL GEOSCIENTISTS OF ONTARIO Notes to Financial Statements Year Ended December 31, 2013

### STATUS AND PURPOSE OF THE ORGANIZATION

The Association of Professional Geoscientists of Ontario was formed on August 15, 2000 by a proclamation of the Ontario Legislature.

The purpose of the Association of Professional Geoscientists of Ontario is:

- to establish and operate a professional association for geoscientists;
- to develop, establish and maintain standards of knowledge and skill, professional qualification, practice and ethics among members of the profession; and
- to share information, promote public awareness of the role of geoscientists and interact on matters relating to professional practice of the geoscientists with registration, licensing or regulatory bodies.

The Association of Professional Geoscientists of Ontario is a tax-exempt, not-for-profit organization.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO). Canadian accounting standards for not-for-profit organizations are part of Canadian GAAP.

#### Revenue recognition

The Association follows the deferral method of accounting for revenue. Membership and registration fees are recognized as revenue in the year to which they relate. Exam fees are recognized when the respective exams are written. Deferred donations are recognized as revenue when earned under the terms of their designated use. Grant revenue is recognized as related expenses are incurred. Revenue from sales of products or services is recognized when title passes to the customer, which generally coincides with the delivery and acceptance of goods. Interest revenue is recognized when earned based on the terms of the investment agreement.

#### Financial instruments policy

The Association initially measures its financial assets and liabilities at fair value. It subsequently measures all its financial assets and financial liabilities at amortized cost, except for investments in equity instruments that are quoted in an active market, which are measured at fair value.

Financial assets subsequently measured at amortized cost include cash, guaranteed investment certificates, and membership fees receivable.

Financial liabilities measured at amortized cost include accounts payable and accrued liabilities.

#### 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### Equipment and leasehold improvements

Equipment and leasehold improvements are stated at cost or deemed cost less accumulated amortization. Equipment and leasehold improvements are amortized over their estimated useful lives at the following rates and methods:

Computer equipment	55%	declining balance method
Computer software	100%	declining balance method
Furniture and fixtures	20%	declining balance method
Leasehold improvements	62 months, (term of lease)	straight-line method

The Association regularly reviews its equipment and leasehold improvements to eliminate obsolete items. Government grants are treated as a reduction of equipment and leasehold improvements cost.

Equipment and leasehold improvements acquired during the year but not placed into use are not amortized until they are placed into use.

#### Assets under capital leases

Assets under capital leases are stated at cost less accumulated amortization. Assets under capital leases are amortized over their estimated useful lives at the following rates and methods:

#### Telephone system

20% declining balance method

Assets under capital leases acquired during the year but not placed into use are not amortized until they are placed into use.

#### Leases

A lease that transfers substantially all of the benefits and risks of ownership is classified as a capital lease. At the inception of a capital lease, an asset and a payment obligation are recorded at an amount equal to the lesser of the present value of the minimum lease payments and the property's fair market value. Assets under capital leases are amortized on a straight-line basis, over their estimated useful lives. All other leases are accounted for as operating leases and rental payments are expensed as incurred.

#### Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make certain estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported periods. Actual results may differ from estimates.

Financial statement items subject to significant management judgment include revenue recognition, the valuation and estimated useful lives of equipment and leasehold improvements, and the completeness of accounts payable and accrued liabilities.

#### 2. MEMBERSHIP FEES RECEIVABLE

On December 31, 2013, membership in the Association stood at 2,777 (2012 - 2,253), and the applications for memberships that were in process of approval at 277 (2012 - 305). Out of the \$293,328 total membership fees receivable at the end of the year, \$287,227 reflect members that have not paid the 2014 fees as at December 31, 2013. At March 31, 2014 the membership fees receivable had been reduced to \$28,108.21.

#### 5. DEFERRED DONATION

In 2006, a designated use donation was made for the establishment of an education fund. This donation has now been fully spent on expenses relating to setting up the fund.

#### 6. DEFERRED REVENUES

The balances in the deferred revenue accounts are comprised of membership fees billed in October of the current calendar year (2013) for memberships for the following calendar year (2014). The full amount of memberships billed at the end of the year is deferred and will be included as income in the following year.

Deferred revenues also result from exam fees received in advance of the exam date. These are recognized as income as the exams are written.

#### 7. CONTINGENCY RESERVE FUND

The APGO Contingency Reserve Fund (CRF) is intended to ensure the Association has the financial resources to defend legal challenges that it might face. The CRF is maintained in the amount equivalent to at least six (6) months of operating requirements of the Association. Council is to annually review the amount of the CRF, the amount of six (6) months of operating requirements of the Association, and ensure that the annual budget will achieve an appropriate operating surplus to allow the CRF to be appropriately maintained.

Cost of addressing appeals against the Registration Committee's decisions are directly deducted from the CRF. No appeals remain outstanding as at the end of the fiscal year.

## 8. STRATEGIC INITIATIVES FUND

In 2009, The General Fund was re-named the Strategic Initiatives Fund to better describe its purpose, which is to fund initiatives stemming from implementation of the Strategic Plan.

## 9. LEASE COMMITMENTS

The Association entered into a new long term lease on October 1, 2012 that expires on November 30, 2017. Under the lease, the Association is required to pay a base annual rent for the five-year term. In addition to the base rent, the Association must pay for its proportionate share of utilities, property taxes, maintenance and other related costs for the leased premises. The lease agreement contains a renewal option to extend the term of the lease for five years at the annual market rate rental value effective as of the date of the renewal. Combined base and additional rent for 2014 is \$7,995.37 per month or \$95,944.44 for the year.

#### 10. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks.

#### Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Association is exposed to credit risk from members. Collection of membership fees is reasonably assured since members need the membership to practice, and there is no history of default.

#### Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association is exposed to this risk mainly in respect of its accounts payable and accrued liabilities and obligations under capital lease. There has been no change to the risk exposures from 2012. The Association monitors its cash balance and cash flows from operations to ensure that it has sufficient liquidity to meet its liabilities when due.

#### Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency rate risk, interest rate risk and other price risk. The Association is mainly exposed to interest rate risk.

#### Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. The Association is not exposed to significant interest rate risk on its cash and guaranteed investment certificates, due to the short-term nature of these investments.
