1. CALL TO ORDER

9. ISSUES

CEO UPDATE

Louis Kan provided the Council with Operational and Projects Update as at October 31, 2017.

Action item 121 - 1: Louis will develop draft KPIs for Council to review at the January 2018 meeting.

Act Modernization

CEO met with:

Louis Kan discussed the proposed "less prescriptive" title-protection amendment drafted by APGO's legal counsel. While this wording incorporates input from the Ministry and would be more discretionary in its application, it may present increased challenges in future legal enforcement proceedings.

Bylaw Update

- APGO in-house IT support developed a central repository for proposed bylaws amendments.
- Proposed amendments will be sent to legal counsel for review and present to council in early 2018 for inclusion in the 2018 AGM notice package to facilitate members' voting.

Professional Development

- Marilen Miguel reported that the MOECC's training session on the ABCs of Preparing Conceptual Site Models (CSM) was a full-house event. Both the Ministry staff and APGO members welcomed the opportunity to have a forum to clarify MOECC expectations around Record Site Condition and Risk Assessment submissions.
- MOECC's positive experience with the CSM event, led to another collaboration with the Ministry to deliver a training session on Modified Generic Risk Assessment (MGRA) tool in January 2018. It will expose attendees to all of the tool's features, how to use them, and how QPs can support their team to prepare high quality MGRA submissions.
- APGO's two-day workshop on Record Site Condition held in October 2018 was also very well received. The workshop will be offered again in the early part of 2018.

APGO'S Online Registration and Paperless System

- Nate Howell reported on the status of APGO's online registration. December 2017 was the target month for the soft launch.
- Budget for the paperless office system was presented to the Council based on the quotes provided by prospective vendors

Corporate Sponsorship

Staff presented the issue about corporate sponsorship. APGO will be drafting policy on this matter.

Policy Concepts Update

Jonathan Rose and Andrew Boddington provided an update about the current political climate at provincial level. Policy Concepts is actively continuing its lobbying work including setting up meetings on behalf of APGO.

Approval of APGO Council Orientation Manual

Council reviewed the updated APGO Council Orientation Manual.

Motion 121-4: Bronwyn Azar moved to approve the updated APGO Council Orientation Manual subject to minor editorial revisions. Seconded by David Leng. All in favour. Carried.

Retired Membership

Aftab Khan reported on the issue about Retired membership. He highlighted that there is no "retired" category in the current regulation. The registrar is seeking guidance from Council on how APGO should handle this particular category to make it distinct from Non-practising category.

Geoscientists Canada (GC) Update

Mark Priddle, GC's President Elect reported on the latest updates about Geoscience Canada.

- Search process for the CEO position is ongoing. Current CEO is retiring in spring 2018.
- GC's strategic plan to be updated in consultation with constituent associations (CAs).
- Qualified Person (QP) Short Course have been presented around to country and is well received by students, faculty as well as some P.Geo.'s.
- Mark stated that he attended the CCCESD meeting. However, there were evidence of resistance to professors registering. He noted that dialogue would be continuing.
- EFG and CETA GC is leading the dialogue on the issues of professional mobility for geoscientists, now that CETA has been signed.
- Mobility Some CA presidents had requested history on this issue; summary has been prepared and will be made available to them.
- Quebec will be invited as an observer to the next GC's AGM, but not at the CEOs' meeting.
- G4S document will be finalized soon, with the aim to roll it out at RFG 2018.
- RFG 2018 is big deal for Canada; expecting 3000 attendees; GC is part of the organizing committee.
