**NOTICE OF HEARING
(re: C-135)**

The Complaints Committee of the Association of Professional Geoscientists of Ontario (“PGO”) has referred allegations against GeoPro Consulting Limited to the Discipline Committee of the PGO. The allegations were referred in accordance with section 21 of the *Professional Geoscientists Act*. The statement of allegations is attached to this notice of hearing. A discipline panel has the authority to hold a hearing under the authority of sections 24-26 of the *Professional Geoscientists Act* and sections 7-19 of Ontario Regulation 258/02, for the purposes of deciding whether the allegations are true and, if a finding is made, what order to make. A discipline panel will convene by videoconference on a date to be set by the Discipline Committee.

To participate in the hearing, you must log in into the videoconference using the login information that will be provided to you by PGO in advance. If you object to dealing with this matter on the merits by videoconference, you may request a hearing in person by delivering a request in writing within ten days to:

IF YOU DO NOT ATTEND AT THE HEARING, EITHER ELECTRONICALLY, PERSONALLY, BY AGENT, OR IN ACCORDANCE WITH THE PRECEDING PARAGRAPHS, THE DISCIPLINE PANEL MAY PROCEED IN YOUR ABSENCE AND YOU WILL NOT BE ENTITLED TO ANY FURTHER NOTICE IN THE PROCEEDINGS.

If the discipline panel makes a finding of professional misconduct, negligence or incompetence, it may make one or more of the following orders:

1. Revoke the member's registration or the certificate holder's certificate of authorization.
2. Suspend the member's registration or the certificate holder's certificate of authorization for a specified period or until he, she or it takes specified steps relating to the practice of professional geoscience.
3. Vary or impose terms, conditions or restrictions on the member's membership until the member has successfully completed specified studies or has obtained specified practical experience under the supervision of another member.
4. Vary or impose terms, conditions or restrictions on the certificate holder's certificate of authorization until the certificate holder takes specified steps relating to the practice of professional geoscience.
5. Direct the member or certificate holder to return all or part of the money paid by a person to the member or certificate holder for his or her services relating to the practice of professional geoscience.

6. Reprimand the member or certificate holder.
7. Publish the name of the member or certificate holder.

Parties are required to disclose to the other parties the evidence they intend to introduce at the hearing pursuant to s. 10 of Ontario Regulation 258/02. In addition, PGO discloses the relevant information in its files to permit you to make full answer and defence unless the information is privileged. STATEMENT OF ALLEGATIONS

1. At all material times, GeoPro Consulting Limited (“GeoPro”) held a certificate of authorization issued by the Association of Professional Geoscientists of Ontario. GeoPro’s certificate of authorization expired on January 1, 2022.
2. At all material times, David Liu was the president of GeoPro.
3. During the material times, from in or around 2019 to 2021, GeoPro offered and provided services that constituted the practice of professional geoscience, including groundwater and soil sampling related to environmental site assessments.
4. It is alleged that GeoPro failed to ensure that its staff had adequate training, supervision, and/or standard operating procedures to perform field investigations and soil and groundwater sampling.
5. It is alleged that GeoPro’s staff routinely used single-use plastic water bottles to collect groundwater samples. It is further alleged that GeoPro’s management instructed staff to use single-use plastic water bottles to collect groundwater samples.
6. It is alleged that GeoPro altered information relating to sampling. In particular:
 - a. It is alleged that borehole locations were changed in reports and/or drawings. It is further alleged that GeoPro’s management instructed staff to change borehole locations in reports.
 - b. It is alleged that GeoPro’s staff used inaccurate dates on chain of custody documents for samples to be accepted by the laboratory. It is further alleged that GeoPro’s management instructed staff to change dates on chain of custody documents.
7. It is alleged that on one occasion in or around 2020 or 2021, David Liu instructed or suggested to an employee to collect and store contaminated groundwater into garbage bags. Ultimately, GeoPro’s staff stored the contaminated groundwater in 20L plastic bins.

8. It is alleged that the conduct described above constitutes professional misconduct pursuant to subsection 24(2) of the *Professional Geoscientists Act* and as defined in paragraph 9 of subsection 16(2) of O Reg 258/02 made under the *Professional Geoscientists Act* (engaging in conduct or an act relevant to the practice of professional geoscience that, having regard to all the circumstances, would reasonably be regarded by the profession as disgraceful, dishonourable or unprofessional).
9. It is further alleged that the conduct described above constitutes negligence as provided for by clause 26(2)(b) of the *Professional Geoscientists Act* and as defined in section 17 of O Reg 258/02.
10. It is further alleged that the conduct described above constitutes incompetence as defined in section 25 of the *Professional Geoscientists Act*.
