- negotiate regional specific waste management issues with the Ministry of the Environment, Conservation and Parks and other appropriate authorities
- ensure that any new waste issues in the region are properly addressed
- provide technical advice and leadership on the environmental assessment process for transportation projects
- provide input into the development of new policy, best practice and legislative recommendations
- project-manage the environmental component of engineering and consultant assignments
- liaise and negotiate with stakeholders, officials and other ministries
- assist in identifying staff training needs, and provide training, mentoring and technical guidance to junior staff
- present project recommendations to senior staff and management
- prepare planning reports, discussion papers and briefing materials
- travel throughout remote areas within Ontario to work on highway construction projects
