NOTICE OF REGISTRATION APPEAL HEARING

The Council of the Association of Professional Geoscientists of Ontario (“PGO”) will hold an appeal hearing under s. 14(1) of the *Professional Geoscientists Act*. Mr. Marrone has requested this hearing so as to appeal the decision of the Registration Committee dated May 11, 2021. A Council appeal panel will convene an electronic hearing at 9:30 am on November 15, 2021, or as soon thereafter as the panel can be convened for the purposes of conducting the hearing.

If you believe that an electronic hearing will cause you significant prejudice you can request that the panel hold a hearing in person by sending a written objection to the Chief Executive Officer. 

At the hearing the Council panel will determine the merits of Mr. Marrone's appeal of the decision of the Registration Committee and can make any order that is permitted by the *Professional Geoscientists Act*. You have consented to the Council panel being composed of a single Councillor, pursuant to section 4.2.1 of the *Statutory Power Procedure Act*.

The parties are required to file with the Chief Executive Officer the documents, in an electronic format, upon which they intend to rely at least ten days before the hearing.
